Terms and Conditions

1. Hire charge (per day): \$635
2. Bond (hall or green hire): \$500
3. Use of carpark area only (per day): \$130
4. The club takes no responsibility for the security of clients' equipment or vehicles on site.
5. The person/s hiring the facilities will be responsible for any damage to the Greens, Premises or Club Property.
6. Premises must be vacated by midnight on the last day of hire.
7. The facilities (particularly the Kitchen & Toilets) are to be cleaned and left in original condition prior to leaving the premises with rubbish to be put into rubbish bags ready for disposal, if not cleaning costs will be deducted from the bond.
8. An Executive Member of the club must be present to oversee the locking up and securing the premises and inspect prior to vacating.
9. Arrangements to be made with the Bar Chairperson for the supply of liquor (if any) and to ensure compliance with the terms of our Liquor License. If a Special License is required the person/s hiring the facilities shall advise the Club Officer 28 days prior to the event and shall be responsible for all associated costs.
10. Car parking to be strictly supervised to ensure that the driveway and all NO PARKING areas are kept clear at all times.
11. Providing all the above conditions have been met and there is no damage to the premises of the Club Property the Bond will be refunded within 7 days.
12. **Under no circumstances shall any person be allowed on the top natural green unless supervised by the Greens Super, and smoking is only permitted in the outside deck on the ground floor or BBQ area. No smoking from the deck upstairs.**
